FUND RAISING CARD PROGRAM INFORMATION FOR THE FUND RAISING GROUP

The Pizza Hut Fund Raising Card program provides an opportunity for NOT-FOR-PROFIT organizations to raise money through the sale of discount cards that may be used at any participating Pizza Hut (see list of participating locations).

Other than the cost to print the cards (see costs below) there is no additional cost to the organization. We will specially design the card with your logo and a brief message (refer to card examples).

Your organization sells the cards to its supporters for \$10 each (non-discountable). There is a series of 6 offers, each of which may be used up to 4 times in any sequence, for a total of 24 offers. Cards will expire on the date on the face of the card.

Current printing costs for the cards are:

Payment for the cards are due on delivery to the group at the local Pizza Hut store through which the cards are ordered.

A signed copy of the TERMS OF AGREEMENT form (page 2 of this form).

YOUR LOGO

Your logo, so that we can personalize your card. If logo is in digital format (pdf, jpg, eps, etc.) it must be 300 dpi or greater for quality print. Logos incorporated in a MS Word document are not usable. Logos may be sent digitally to tiovino@pizzahutfw.com.

If your logo is only available in printed format, please provide a letterhead, brochure, etc. with a sharp image and we will scan the logo for use. Faxed logos are of poor quality and are not usable. If you do not have a logo we will create a theme-oriented logo for you.

CARD QUANTITY

Cards are available in the quantities above. Contact us for costs in quantities higher than 2000.

WHAT WE WILL DO

SPECIALLY DESIGN YOUR CARD

Our specially designed cards demonstrate group pride and increase saleability. A proof will be sent to you for your approval within 3-5 working days after receipt of your logo.

PRINT AND DELIVER YOUR CARDS

After receiving your final approval of the proof your cards will be printed (generally in 5-7 working days) and delivered to the originating Pizza Hut. Payment is due before or at time of pickup/delivery to you.

2. SELLING PRICE OF THE CARDS by the group will be \$10 each and non-discounted.

3. COST OF PRINTING will be the responsibility of the selling group and will be at \$_____ per _____ cards.
If sales organization is tax-exempt, please provide a copy of the tax-exempt certificate. Payment is due when cards are picked up from the participation store.

4. UNSOLD CARDS remaining at the end of the sales period must be returned to the local Pizza Hut within 10 days.

5. EXPIRATION DATE will be listed on the face of the card and will vary based on quantity and be no later than 6 months after the start of the sales period.

6. LOCATION OF SALES -- Cards may not be sold on the premises of any Pizza Hut location.

7. PARTICIPATING LOCATIONS -- Cards are valid only at the Pizza Hut locations listed as participating stores or specifically stated on the face of the card.

8. AGREEMENT -- Organization representative agrees that cards will be sold for the sole purpose of supporting the not-for-profit group and for no other purpose, that cards will not be duplicated in any manner, that unsold cards will be returned as described above and that all other captioned items above are agreed to.
